#### I. Approval of Minutes

McCarthy has been called and several issues arose. First, some of the exhaust fans need servicing. Second, the source of the noise on the fourth floor is still a mystery.

# VI. Taxes

Still no word on whether Sergio has got the box O'Neill sent with paperwork last spring. Sergio says he has only the ones left for him in September.

#### VII. Management

We're coming up on the time to decide whether to renew our contract with Chatel. We have been extremely dissatisfied with service to date. Nothing is getting done and we are working more now than we were before they were involved.

By a vote of three (O'Neill, Davidson, Trivedi) to one (Wrenn) the board has decided not to renew the contract with Chatel. A notice will be drafted and circulated for approval over the next week.
